# TAX FILE NUMBER DECLARATION

To ensure the correct amount of PAYG tax is withheld on your wages, it's essential to submit a Tax File Number (TFN) declaration **via your Astute payroll** account **before your first pay date**. Please use the following guide to assist with submitting your TFN declaration.

## START A TFN DECLARATION

- Go to Astute payroll portal <u>agrilabour.astutepayroll.com/agrilabour/auth/login</u> and login.
- Go to **Profile** tab, on the right side of the page.
- Select Tax & Super.

- Enter your **Tax File Number** in the rectangle box. If you do not have a Tax File Number and are applying for one with the ATO, leave the space blank.
- Are you an Australian resident for tax purposes or a working holiday maker?
  - If you hold a working holiday visa (subclass 417 or 462), you need to select the third option 'A working holiday maker'.
  - If you do not hold a visa of subclass 417 or 462, you should select either 'An Australian resident for tax purposes' or 'A foreign resident for tax purposes'.

  - If you are applying for a Tax File Number with the ATO, select the third option
    \*\*Note: If you select this option, you'll need to re-submit a TFN declaration once you have received your TFN from the ATO. This needs to be done within 28 days from the date you submit your first TFN declaration. Otherwise your PAYG tax will be withheld at the highest tax rate after 28 days.\*\*
